

Non-school candidate enrolment form 2024

(Read this prior to completing the form)

General information

Definition

To be a non-school candidate in an ATAR (Australian Tertiary Admissions Rank) course examination means that the candidate will not have a school mark to contribute to their final scaled mark for the course. That is, the scaled mark for the course is calculated on the examination mark only. Non-school candidates do not receive an ATAR course report and will not have the course listed on their WASSA (Western Australian Statement of Student Achievement). As a non-school candidate, the examination does not contribute towards meeting the requirements for the WACE (Western Australian Certificate of Education).

Eligibility

Typically, students at a school cannot sit an ATAR course examination as a non-school candidate. An individual may enrol to sit an ATAR course examination as a non-school candidate in the event that the individual is:

- seeking entry to university as a mature-age¹ applicant (that is, at least 19 years old as of 1 March 2024), or
- a student who has previously completed Year 12, or
- a Year 12 student undertaking an Interstate Language course examination or a Chinese: First Language
 course examination, or a background language course examination in French, German, Hindi, Italian or
 Korean where the course is not offered by the school, and the student is enrolled to sit at least three
 other ATAR course examinations as a school candidate in that year.

Rules

- 1. To enrol as a non-school candidate in an Interstate Languages examination or in the Chinese: First Language, or French, German, Hindi, Italian or Korean Background Language course examination, the candidate must be enrolled to sit at least three other ATAR course examinations in that year.
- 2. An individual may not enrol in an Interstate Language examination at the same time as being enrolled in that course with the State that hosts the language.
- 3. An individual may not enrol in more than one Interstate Language examination.
- 4. Non-school candidates are responsible for ensuring that they are aware of the timetable for any practical and written examinations for which they are enrolled. Non-school candidates are responsible for downloading from the student portal https://studentportal.scsa.wa.edu.au their practical and written *Personalised Examination Timetable*.
- 5. Non-school candidates must sit the examination at a designated Western Australian examination centre. Where there is a practical examination component, a non-school candidate located outside the Perth metropolitan area is responsible for all associated travel costs.

Consequences of enrolling as a non-school candidate

An individual enrolled in an ATAR course examination as a non-school candidate will not be considered
for a sickness/misadventure claim. That is, non-school candidates who suffer a sickness or
misadventure prior to or during the ATAR course examination caused by them, a third party or the
School Curriculum and Standards Authority (the Authority) are unable to receive consideration for their
examination mark.

¹ As defined by TISC – a mature-age student is a person who will be 20 years of age or over before 1 March 2025.

2. An individual enrolled in an ATAR course examination as a non-school candidate is unable to use the mark from that examination to contribute to the achievement of an Authority exhibition or award.

Procedures for enrolment

- 1. To enrol to sit an ATAR course examination as a non-school candidate, the candidate uses the *Non-school candidate enrolment form* and payment section in this document.
- 2. The completed form must be received at the Authority by Thursday, 28 March 2024.
- 3. A fee of \$60 (GST exempt) for courses with only a written examination or \$120 (GST exempt) for courses with both practical and written examinations is payable.
- Enrolment as a non-school candidate in the 2024 ATAR course examinations cannot be accepted after Thursday, 28 March 2024.
- 5. Candidates enrolling as a non-school candidate in Background or First Language course examinations, must:
 - complete an *Application for permission to enrol in a WACE language course*, which can be accessed through the student portal at https://studentportal.scsa.wa.edu.au. For further information, email languagesenrolment@scsa.wa.edu.au.
 - read the relevant language course syllabus and *Practical (Oral) Requirements* booklet (where applicable), available on the relevant course page on the Authority website (at https://senior-secondary.scsa.wa.edu.au/syllabus-and-support-materials/languages).
- 6. Candidates undertaking language course examinations through Interstate Language offerings can access the relevant syllabus through the Interstate Languages page on the Authority website at https://senior-secondary.scsa.wa.edu.au/syllabus-and-support-materials/languages/interstate-languages.
- 7. A mature-age student, or a student who has previously completed Year 12, applying to sit the ATAR EAL/D examination as a non-school candidate must have eligibility approval from the Authority to enrol in the Year 12 ATAR EAL/D course. Responsibilities of schools

Schools (principal or school representative) are required to sign the *Declaration by principal/school representative* section of the form. In signing the form, the school is declaring that the student:

- is unable to study the language course (i.e. Chinese: First Language, or French, German, Hindi, Italian or Korean Background Language) for which they are enrolling as a non-school candidate at that school during the current year, or
- is unable to study the Interstate Language course for which they are enrolling as a non-school candidate at that school during the current year, **or**
- is seeking entry to university as a mature-age applicant, or
- has previously completed Year 12, and
- has been informed of the consequences of enrolling as a non-school candidate in an examination and understands the implications of this enrolment.

To enrol in an ATAR course examination as a non-school candidate, a non-refundable fee is payable as follows:

- for courses with only a written examination, the fee is \$60 (GST exempt). For Languages, the following courses have only a written examination: **Chinese: First Language** and **Indonesian: First Language** (final year 2024).
- for courses with both practical and written examinations, the fee is \$120 (GST exempt).

Payment is due by **Thursday, 28 March 2024** and must be received at the time of enrolment. Enrolments as a non-school candidate will not be processed without payment.
