## **2025 SYLLABUS DELIVERY AUDIT (SDA)**

As part of the School Curriculum and Standards Authority's (the Authority) 2025 moderation process, the documentation for Years 11 and 12 Foundation, General and ATAR courses listed in Attachment 1 will be audited.

### **2025 SDA – Years 11 and 12 Foundation, General and ATAR courses**

All schools are required to submit to the Authority the following documents for the selected Years 11 and 12 Foundation, General and ATAR courses they will deliver in 2025:

- a course outline
- an assessment outline.

The Authority will review the documents and provide a report for each course to the school. The report will outline actions the school needs to take, if required, to ensure the documents comply with the 2025 Western Australian Certificate of Education (WACE) requirements.

### **Process**

The 2025 SDA uploading and reporting processes are the same as for 2024.

Schools are advised that:

- the process will be conducted through the Student Information Records System 2 (SIRS2). The URL for the SDA 2025 page is <https://sirs2.scsa.wa.edu.au> (Note: the page is **not** accessible through the current SIRS portal)
- the upload of the required documents can only be completed between **9.00 am Tuesday, 28 January 2025 and 4.00 pm Monday, 17 February 2025**. Schools will not be able to upload documents after this date.

While the Authority provides sample course and assessment outlines for guidance, it is the expectation of the Authority that teachers will develop documents customised to reflect their school's context and the needs of the student cohort.

Principals are requested to ensure that:

- staff responsible for the uploading of documents follow the procedure outlined in the attached *Syllabus delivery audit 2025 School coordinator handbook*
- all teachers of the selected courses, are provided with a copy of the attached *Syllabus delivery audit 2025 Teacher and Head of Learning Area (HoLA) handbook*.
